## (8) PRESENTATION FROM SCISD

SCISD Superintendent Oscar Aguero asked for time to present to the court, but he is currently out of town. This item will appear on a future agenda.

### (9) DEBTBOOK RENEWAL AGREEMENT

Treasurer Jennifer Henderson suggested renewing the agreement for one year. She has asked for a new, revised contract that does not include auto renew. Treasurer will be researching other companies that provide the same services. New revised contract will be presented in two weeks. Motion to allow Judge Bradley or Treasurer Henderson to sign contract by Commissioner Chris Meador. Seconded by Commissioner Gary Gibson. Motion passes.

### (10) TAC HEBP RENEWAL FY 2025

Treasurer Jennifer Henderson presented the cost differences to the court. She proposed that the county cover the increases from \$900 to \$932 for employee only coverage as well as the increase from \$1,200 to \$1,240 for employee plus dependent(s) coverage. Motion to accept and approve the changes as presented by Commissioner Kirk Griffin. Seconded by Commissioner Chris Meador. Motion passes.

#### (11) PUBLIC HEARING

County Judge Charlie Bradley commenced the hearing at 9:29 a.m. and opened up the floor to the public. Purpose for the public hearing is to address concerns regarding the creation of a Reinvestment Zone to be known as Schleicher County Reinvestment Zone-Rockefeller for purposes of tax abatement to provide economic development within the county. Mr. Bass, Mr. Westlake and Ms. Kirk were present to address concerns from the public.

# (15) AMENDMENT TO TAX ABATEMENT AGREEMENT

Consider Amendment to Tax Abatement Agreement with Mittel Rockefeller for the construction of a storage power project of approximately 200 MW with an estimated cost of

\$58 million to the county. Motion to approve by Commissioner Steve Nelson. Court needed to take action on this agenda item. Seconded by County Judge Charlie Bradley. Took vote – 2 yes – 3 no – Motion fails.

#### (14) STORAGE CAPACITY

Consider adoption of a Tax Abatement Agreement with Mittel Rockefeller Storage, LLC. Motion to accept and approve by Commissioner Chris Meador. Court needed to take action on this agenda item. Seconded by County Judge Charlie Bradley. Vote was taken 1 yes – 4 no – Motion fails.

### (13) ROAD USE AGREEMENT

No vote taken due to the fact that the previous agenda item (14) failed.

### (16) LONE STAR CONSULTING

Treasurer Jennifer Henderson addressed the court citing the benefits to entering into an agreement. The cost is \$4,000 monthly, the funds would have to be located in the current budget, the cost can be budgeted for in next year's budget. Motion to enter into an agreement and fund out of the Road Department's budget by Commissioner Kirk Griffin. Seconded by Commissioner Chris Meador. Motion passes.

## (17) MOU WITH CITY OF ELDORADO

County Judge Charlie Bradley addressed the court stating that County Attorney Clint Griffin drew up a contract regarding the use of county equipment and personnel to clean up vacant lots within the city limits to possibly put them back on the tax roll. Motion to accept and approve by Commissioner Gary Gibson. Seconded by Commissioner Steve Nelson. Motion passes.

## (18) SHERIFF AND CONSTABLE FEES FOR 2025

County Judge Charlie Bradley presented in Sheriff Jason Chatham's absence. There will be no changes to the fees in 2025. The fees will remain as they were for 2024. Motion to accept and approve the Sheriff fees for 2025 without changes by Commissioner Chris Meador. Seconded by Commissioner Gary Gibson. Motion passes.

## (19) ANLC LEASE PURCHASE QUOTE

Treasurer Jennifer Henderson presented on behalf of Sheriff Jason Chatham. The sheriff's office has a lease in place that allows for two new vehicles each year on a four-year lease agreement. The vehicles that were not ready last year are ready now. Asking the court to approve the quote from ANLC to, in essence, pick up where we left off. \$39,240 is already built into this year's budget. Motion to accept and approve by Commissioner Chris Meador. Seconded by Commissioner Steve Nelson. Motion passes.

# (20) COMMUNICATIONS RADIO TOWER

County Judge Charlie Bradley notified the court that the light on our communications tower is out and the county is out of compliance. Sheriff Jason Chatham has sought two different quotes — The first, replace the light at the top with a red light (only sufficient for nighttime) for \$11,1111 and the tower would have to be re-painted for an additional \$8,000

- The second option is to replace the light at the top with a red light for nighttime and a white light for daytime for \$14,000.

Judge Bradley also notified the court that the guidewires were out of compliance. He suggested replacing the guidewires as well as the turnbuckles on the tower for a cost of \$23,500.

Motion to declare an emergency and approve up to \$40,000 to replace the light on top of the tower, replace the guidewires and the turnbuckles by Commissioner Kirk Griffin. Seconded by Commissioner Chris Meador. Motion passes.

### (21) BURN BAN

Motion to enact burn ban by Commissioner Chris Meador. Seconded by Commissioner Gary Gibson. Motion passes and burn ban goes into effect.

None at this time.

### (24) NEW BUSINESS

County Judge Charlie Bradley reported to the court that there had been a break in at the County Pool over the weekend. He has already contacted Angelo Overhead Door to hopefully repair the existing doors rather than replace. Treasurer Henderson will contact VGI for possible quotes on camera installation at several locations in the county.

## (25) ADJOURN

With nothing further to discuss motion to adjourn by Commissioner Chris Meador. Seconded by Commissioner Gary Gibson. Motion passes, the meeting adjourned at 11:40 a.m.
