Michelle Bischoffberger gave a report on the progress of the library. The building should be finished by February. Both ramps at the front of the building are now ADA compliant. Railing is Kelly green to match the school color. They will be replacing the third ramp on the right side of the building to make it ADA compliant as well. The contractors and plumbers are working on replacing all of the sewer pipes to the city line. Last Tuesday there was a grant received and goals were met. \$930,000 has been raised altogether. The library is in great standing with all the goals for the challenge grant have been met. The contractors are doing a wonderful job, they answer any and all questions. She also gave an open invitation for anyone who would like to go see the progress.

#### **(7) AgriLife Salary Contribution for 2025**

County Judge Charlie Bradley presented the agreement. No changes are being made. We have signed it every year, would encourage the court to sign it again. Motion to accept the agreement and enter for 2025 Commissioner Gary Gibson questioned what would have to be done in order for our agent to be paid more. County Judge Charlie Bradley gave a brief overview, could not sign in the system until after November 2, 2024. If we are approved, court should ratify and approve. Motion to approve by Commissioner Gary Gibson. Seconded by Commissioner Steve Nelson, Judge Bradley abstained – motion passes.

He will ask several questions regarding the improvement of our county. County Judge Charlie Bradley received an email and he will be submitting our request to receive the allotted funds from TxDOT.

County Clerk asked the court to schedule the canvass for the November 5, 2024 General Election. Canvassing is scheduled for 2pm on Thursday, November 14, 2024 per commissioners.

Commissioner Gary Gibson inquired about the cement pouring at the cemetery. Someone asked him if the county was no longer maintaining the cemetery. Judge Charlie Bradley discussed the steps that the county takes in order to maintain the cemetery.

Commissioner Steve Nelson mentioned that he received a complaint from a citizen about the metal surrounding at the County Park.

A brief discussion was held regarding the metal plate at the entrance of the Memorial Building and how to possibly fix it. The corners of the plate are lifted. The plate is covering a water line from the city.

Judge Charlie Bradley mentioned that the plumber that received the bid to do the work to install a generator at the civic center has not completed the work yet. The bid was granted in April. Judge Bradley will reach out to the individual and if the work cannot be done this week, he will reach out to the contractors that are working on the construction at the library.
