

## BOOKING AGREEMENT

### SCHLEICHER COUNTY RODEO SLAB

**THE USE OF THE RODEO SLAB REQUIRES A \$25 DOLLAR USAGE FEE AND \$100 DOLLAR DEPOSIT. THE \$25 DOLLAR RENTAL FEE MUST BE PAID ON THE DATE RESERVATION IS MADE AND THE DEPOSIT BY THE DATE OF YOUR EVENT.**

1. Restrooms are not available at the Rodeo Slab. It is the Sole Responsibility of the Renter to provide Portable toilets for guest.
2. Any event holding a dance and/or allowing alcohol to be present will be required to have no less than 2 security officers. Arrangements can be made with Schleicher County Sheriff's Office by calling {325} 853-2737. A written statement from Sheriff's office will be required for you to have your event.
3. All trash needs to be picked up at Rodeo Slab and in the parking lot.
4. All events need to end by 12 A.M. Sunday through Friday and 1 A.M. on Saturdays.
5. To avoid losing your deposit please cancel your event at least 15 days prior to event.
6. Rentals may not be booked more than a year in advance. All bookings are on a first come first serve basis.

**\*VIOLATION OF THE RULES WILL RESULT IN THE FORFEITURE OF THE ENTIRE DEPOSIT.**

**\*In accordance to the Local Government Code 154.025, when a debt owed to the County is reported, all future payments owed to that person from Schleicher County must be withheld and applied to the debt owed until paid in full.**
